- 2. Class 11/12 students from Arts & Commerce streams opting for Computer/Informatics Practices subject shall pay Laboratory fee of Rs. 300/- only in addition to the above fees. Arts Students opting for Geography subject shall pay Rs. 100/- only in addition to the above fee.
- 3. Schools providing Uniforms, T. Shirts, Neck Tie, Belt etc. shall get the rates approved by the respective School Management and Development Committees(SMDCs).
- 4. NBSE fee shall be modified in accordance with the notifications being issued by the Board from time to time.
